Vice – President's Report

April proved to be a very busy month for us at PVA. On April 9th I attended a meeting sponsored by Congressman Steven Horsford's Veterans Advisory Board. The Congressman was in Washington to present a bill to bring jobs to Nevada in the form of a new highway connecting Nevada and Arizona. The meeting was hosted by Porche Hurley, Military and Veterans Liaison, and Christie Omelia, Director of Constituents Services.

The meeting covered many concerns, among them, complaints about the VA Hospital. One main problem that was addressed was Blue Water Sailors. Blue Water Sailors are those who served on deep water navy and coastguard vessels. The VA reports that the exposure of Viet Nam era Blue Water Veterans to Agent Orange cannot be reasonably determined due to lack of data on environmental concentrations of Agent Orange. The claims that are considered are those ships that went to inland waterways, and those that docked. Congressman Horsford will continue to work with this case.

On April 14th, NVPVA President, Daniel Kaminski and I attended a veterans roundtable hosted by Senator Dean Heller along with Margot Allen who is our liaison and always ready to listen when we have concerns or complaints. I personally spoke to Senator Heller's staff while in Washington, and they assured me he is 100% behind our veterans. During the meeting he took the time to speak with each representative to let us know that he is still working hard on our behalf. There are bills pending in Washington that he is pushing and he is going to add his name to others when he returns to Washington. A big thanks to Senator Heller and his staff for the work he has already done, and will continue to do. The meeting was well attended by many organizations. We all left the meeting feeling that our concerns will be heard on the hill in Washington.

Next, on April 22nd we attend the Town Hall meeting hosted by Congressman Horsford and his staff. The Congressman took the time to listen to all complaints. A lot of questions were asked about the claims of veterans and why Reno was the worst when it came to reviewing. We were assured that things were getting better and more money has been allocated to hire more agents to speed the process up.

These meetings that were held will be ongoing and we at Nevada PVA want to thank Senator Heller and Congressman Horsford and their staff for their time and the work that they are doing. Thanks also to Board Member, Roger Dauffenbach, for coming down from Reno to attend the Town Hall Meeting.

On April 24th our office was closed for a special event hosted by Better Life Mobility in the form of a wheelchair slalom. The slalom allowed able bodied people to get into a wheelchair to experience what it's like to have to use it. We thank Better Life Mobility for providing the facility and parking lot for this event. The lunch they provided was super and we look forward to doing other events with them.

Last but not least, on April 26th, our chapter ED Julie Johnson held her second annual Walk, Run and Roll at Bunker Park, with the support of VA/SCI staff, members, the chapter, family, friends and other organizations behind her, it turned out to be a successful day Thanks to Jamie Johnson for a great lunch. This was the perfect ending for our month of Public Awareness.

New Program Open to Eligible Veterans from Rebuilding Together Southern Nevada

Major rehabilitation of 10-15 veterans homes. They will be doing HVAC replacement, insulation, double pane windows, basic weatherization, etc.

To qualify, the homeowner must be a veteran and not exceed 80% Area Median Income. For a single person living alone that's about \$36,000. That number goes up depending on the number of occupants living in the home.

The only caveat is that the homeowner must pay back a portion of the funding **IF** they sell the home in a certain amount of time. Go to RTSNV.org to see this and other programs that may be available to you.

Unauthorized Non-VA Emergency Medical Care

At one point or another, we all have had a medical situation arise requiring 9-1-1 to be called and being transported by emergency services to the nearest trauma center to receive the needed care. After knowing we are going to receive the proper care needed, we start to wonder who is going to pay the bill. To be determined an emergency, it has to be decided "if in the mind of an average person, it was a life-threatening situation or that if a delay in care would be life threatening." This is often referred to as the *prudent layperson standard*.

For veterans, many look to the US Department of Veterans' Affairs (VA), to pay for the non-VA emergency care. A lot of veterans believe that because they had served in the Armed Forces they are eligible to have the VA pay. This is not the case and it is not as simple as having served that would ensure the VA pays for unauthorized non-VA medical care of emergency care. After all, we are dealing with the federal government so there has to be more to it than that and there is. There are some questions that need to be answered before the VA can determine if they are going to pay.

First, is the veteran enrolled in the VA Healthcare System? If they are the VA would have to then determine if it is an emergency by applying the prudent layperson standard mentioned earlier.

Now that they have determined the veteran is enrolled and it was an emergency, the VA would have to determine if VA facilities were not feasibly available. This means that an attempt to use VA or other federal facilities beforehand would not have been reasonable, sound, wise, or practical, or that treatment had been denied or would have been denied. This also includes the VA being notified of the emergency care within 72 hours from admission. You must remember that when you call 9-1-1, the emergency services are required to transport you to the nearest trauma center that can provide the needed care, even though you may request emergency services to transport to the nearest VA medical facility. The VA Medical Centers are not registered trauma centers and may route them to the nearest trauma center.

Since payment may be limited to the point when your condition is stable enough for you to be transported to the nearest VA Medical Center, someone will need to contact the nearest VA Medical facility on your behalf and inform them of your admission, preferable as soon as possible, if that is not possible, then within 72-hours of your admission.

The VA then must determine if treatment for your non-VA emergency care was for a service-connected disability, or for a non-service connected disability associated with and held to be aggravating your service-connected disability; or any condition, if you are an active participant in the Chapter 31 Vocational Rehabilitation program, and you need treatment to make it possible for you to enter into a course of training, or to prevent interruption of a course of training or other approved reason. If it was determined to be a service connected disability, the VA will pay for your non-VA emergency care.

If the VA determines it was for a non-service connected disability, the VA may pay for emergency care only if **ALL** of the following conditions are met:

- ◆ The episode of care cannot be paid under VA authority—and—
- Based on average knowledge of health and medicine (prudent layperson standard) you reasonable expected that delay in seeking immediate medical attention would have been hazardous to your life or health—and—
- ♦ A VA or other federal facility/provider was not feasible available—and—
- You have received VA medical care within a 24-month period preceding the non-VA emergency care and -
- ♦ You are financial liable to the health care provider for the emergency care—and—
- ◆ The services were furnished by an Emergency Department or similar facility held out to provide emergency care to the general public—and—
- ♦ You have no other coverage under a health plan (including Medicare, Medicaid, and Worker's Compensation) and—
- You have no contractual or legal recourse against a third party that would, in whole, extinguish your liability.

Unauthorized Non-VA Emergency Medical Care

One thing to remember is that if any other carrier pays any portion, the VA is unable to pay, unless the facility refunds the first payer first. The VA is required to pay all—or none of the bill. Sometimes, you will have to insist the treating facility bill the VA directly. Most of the facilities do but not unless directed to.

You may continue to receive billing statements or letters from the facility or creditors even after the bill has been submitted to the VA. This is because it can be a slow process on the VA's behalf and the bill continues not to be paid. These bills are ultimately your responsibility even if it has been submitted to the VA, and can affect your credit report if they go unpaid. You must talk to the creditors and can refer them to the VA. You may also contact your National Service Officer (NSO) who can assist you with this. Or you can contact the VA Fee Basis at the responsible VA Medical Center. IF possible, you can pay the bill so it does not affect your credit report and seek re-imbursement from the VA. This can also be a slow process.




