Over the years Nevada PVA has become the leading provider of sports, recreation and wellness programs for veterans with SCI. Our program includes the following services: (1) Step Outside: (2) Adopt - A- Vet: (3) Sports (for physical stability) and (4) Paralympic Children's sports activity clinics. Step Outside enables the veterans to get out of their home and take part in their community. Adopt -A- Vet provides for the basic needs for veterans. Through sports we offer bowling, trapshoot and fishing outings to help enhance mental and physical stability.

Outreach and Education:

We have a bi-monthly newsletter and bi-monthly E-news Updates these are sent out to our members, fellow chapters, and spinal cord clinics. We also provide support to veterans and their families as well as our spinal cord nurses and social worker at both hospitals, through our education scholarships. Nevada PVA participates in numerous community outreach events including The Veterans Service Fair and veteran's health fairs.
