Included with this program we reach out to our fellow NV PVA members to do "Buddy Checks" to ensure our veterans know we are here for them and to remind them of all the great programs we have to offer.

**Adaptive Sports & Recreation Program**

This program achieved record participation with the largest Nevada team ever sent to the National Veteran Wheelchair Games, demonstrating increased veteran engagement in year-round adaptive sports and fitness training. The program expanded to include a comprehensive 3-day Northern Nevada event featuring outdoor activities and sports clinics, participation in two Military Sports Camps, and the "Step Outside" initiative that successfully encourages veterans to leave their homes and actively participate in community activities.

**Adopt-A-Vet Program**

This essential support program provided critical basic needs assistance to veterans through monthly deliveries of food bags and hygiene kits, monthly food gift cards for veterans in rural and Northern Nevada areas, and distribution of food and hygiene supplies to 600 veterans at service fairs throughout the year. The program's impact extended beyond basic necessities to include donations of clothing, shoes, household items, and transportation assistance through bus passes.
