

#### Advocacy/Legislative News

We completed another successful PVA Advocacy and Legislation Seminar. We sent two representatives this year to meet with our Members of Congress and their representatives. This year PVA focused on Protection of Specialized Services. PVA believes that:

- Congress must provide sufficient funding for the VA to hire additional clinicians, including physicians, nurses, psychologists, social workers and rehabilitation therapists to meet demand for services in the SCI/D system of care.
- ♦ Congressional oversight is needed to ensure that VA is meeting capacity requirements within the recognized specialized systems of care.
- Congress must ensure veterans who receive care in the community retain current protections unique to VA healthcare under Title 38, particularly including medical malpractice remedies, clinical appeal rights, no-cost accredited representation, and Congressional oversight and public accountability.

Also of great importance to PVA is to Expand Eligibility for the VA Comprehensive Caregiver Program. Currently the program is only available to a veteran seriously injured due to military service on or after September 11, 2001. Congress must eliminate the unjust date of injury requirement and include "service-connected illness" as a criterion for the program. Doing so will give the majority of veterans' caregivers access to critically needed support services.

- Congress must pass the bipartisan S. 2193 the "Caring for our Veterans Act," passed out of the Senate VA Committee in November 2017. This legislation would incrementally expand the caregiver program to veterans seriously injured during and prior to the Vietnam War. After a two-year period the program would be open to all eras.
- Congress must also pass H.R. 1802 the "CARE for All Veterans Act." This legislation would expand eligibility to the care-giver program to include veterans of all eras with service-connected illnesses.

Also on the agenda for the legislative seminar were:

- ♦ Air Carrier Access Amendments Act
- ♦ ADA Notification
- ♦ Improve Benefits for Catastrophically Disabled Veterans
- ♦ Automobile Adaptive Equipment
- ♦ Rapid Appeals Modernization Program (RAMP)
- ♦ Congress Targets Safety Net Programs



Nevada PVA offers three (3) annual full-time scholarships in the amount of \$2,000 each. It is open to any student attending a college or university as long as they are a member or a family member of a Nevada PVA member. Deadline for application submission is June 30, 2018 and awards will be made in August in time for the fall semester. The money will be sent directly to the college or university. #### VA MORTGAGE SCAMS: THE EPIDEMIC

If you have been watching the news lately, you might have noticed there have been a multitude of scams noted in the media. This could be from phishing (email) scams to phone call scams to support the King of Nigeria, Social Security scams, etc.

However, this scam problem has now started to focus on a benefit that we as Veterans served our country for: the VA Home Loan.

Please review the following statement:

"The Consumer Financial Protection Bureau and the Veterans Affairs Department issued a joint "Warning Order" asking service members and veterans with VA loans to beware of "too good to be true" unsolicited offers that could turn out to be financial scams.

Among the types of offers that should set off alarms, according to a CFPB blog post:

- Lower-than-expected interest rate offers that don't include specifics regarding term length, rate type (adjustable or fixed), or points.
- Promises of skipped mortgage payments, a tactic expressly forbidden by the VA for vendors of the Interest Rate Reduction Refinance Loan.
- Escrow refund promises that appear linked to specific amounts, but may depend on how much money is left in escrow when the loan closes.
- Aggressive or unusual sales tactics, such as repeated phone calls or offers to refinance almost immediately after closing.

VA home loan recipients who believe they're being hassled by scammers or think they've unknowingly entered into a scam can file a CFPB complaint, or call the bureau at 855-411-2372."

Going forward, make sure you work with a recognized lender, and if possible, one you can sit across a desk from. This will ensure your time and efforts are not being wasted.

#### **Clothing Allowance**

The following is the amended Department of Veterans Affairs regulation regarding clothing allowances. The amendment provides for an annual clothing allowance for each qualifying prosthetic or orthopedic appliance worn or used by a veteran for a service-connected disability or disabilities that wears out or tears a single article of the veteran's clothing and for each physician-prescribed medication used by a veteran for a skin condition that is due to a service —connected disability that affects a single outer garment.

The amendment also provides two annual clothing allowance if a veteran wears or uses more than one qualifying prosthetic or orthopedic appliance, physician-prescribed medication for more than one skin condition, or an appliance and a medication for a service-connected disability or disabilities and the appliance(s) or medication(s) together cause a single article of clothing to wear out faster than if affected by a single appliance or medication.

Please notify my office if the above pertains to you. We will get VA form 21-8678 (Clothing Allowance Application) sent to you promptly. Clothing allowance payments are usually paid out the end of August of each year. If you have further questions, please contact my office 702-791-9000 ext. 14458.

## Step Outside Program

The Chapter will fund the member and one (1) guest for participation in or attending basketball, soccer, bowling etc., events or will reimburse the member and one (1) guest to attend shows, movies, plays or lunch/dinner, in a sit-down restaurant environment, **not** fast food.

The amount of the funding will be capped at \$100.00 per quarter, per member.

In order to have access to these funds, the member must submit receipts and a short review of the event attended, which will be placed in the newsletter. Receipts and the review **must be** submitted within three (3) weeks of having attended the event in order to be eligible for reimbursement.

This program is designed to get our members out an about in a social setting.

**ADDEENDUM**: You do not need to spend \$100.00 on any one event, the money is \$100.00 **per quarter** so if you pay \$10.00 ten times for movies you still get the funding. However, you must submit the receipt and the **write up** within three weeks of the event. **DO NOT SAVE YOUR RECEIPTS UNTIL YOU ACCUMULATE** \$100.00, NEVADA PVA WILL KEEP TRACK OF THE FUNDS.
